Methodology

Penn Schoen Berland (PSB) conducted online interviews on March 21-22, 2012 among n=1,000 American adults. The margin of error for the entire sample is +/- 3.1 at the 95% confidence level.

Note: All numbers cited represent percentages (%). Some percentages may add to more or less than 100% due to rounding error.
